EXPLORER PROGRAM: Chief Wilkes informed the board the explorer program will have to be put on hold for now. Battalion Chief O'Neill had a change in career so he is unable to implement the program and staff does not currently have to the time to develop the program.

TRAINING REPORT: Training Chief Eric Alvarez was not in attendance.

FIREFIGHTERS' ASSOC. REPORT: Association President Aaron Branscomb announced the association fundraiser will be September 11th, 2021, during the open house for Station 54. Staff is currently working on four new volunteer firefighters as well.

CHIEF'S REPORT:

Chief Wilkes informed the board there were 62 calls in April. A vehicle fire caused a 3-5 acre fire and then there were multiple escaped control burns throughout the month. On May 17th, 2021, Calfire will implement a burn ban. Tony Madrigal stated there was an excellent turnout for an accident north of town. Chief Wilkes said the accident blocked one lane, and they landed two helicopters. Ridgewood Ranch and Brooktrails helped with mutual aid response. Chief Wilkes commended the Willits Police

Department for their response to assist with traffic control during the accident. During one of our traffic accidents, our duty rig was struck during traffic control. Luckily our firefighter was missed. There were two engines and one duty rig in front of the hit duty rig. The Caltrans traffic sign was on to warn drivers of the accident as well. The driver did not have insurance and did not have a valid license. Chief Wilkes stated one of the most dangerous things for a firefighter is traffic control. Drivers have not changed or slowed down even with the Caltrans sign.
