EXPLORER PROGRAM: Skip Lucier reported as long as the District are within the rules and regulations under Learning for Life, the District should not need to purchase extra coverage. Tony Madrigal stated the Explorers will be limited of what the can and cannot participate in. Tony Madrigal also suggested a board for the explorer program and who may want to volunteer to be on the board. Aaron Branscomb and Skip Lucier offered to join the Explorer Program board. Skip Lucier also suggested volunteer firefighters to mentor and oversee the explorers.

TRAINING REPORT: Training Chief Eric Alvarez reported the last drill consisted of ropes, knots, hardware and software for the boom. He is hoping the new firefighters will be able to attend. Training Chief Eric Alvarez thanked Arnie Mello for the permission to use the old hospital for training. Training Chief Eric Alvarez his hoping to use the thermal imaging camera at the old hospital which will help train the firefighters in a blackout and smoke filled environment. Future trainings will include how to cut open electric cars such as Tesla's. Training Chief Eric Alvarez stated when everything settles he will offer classes for an in house driver operator as well as hoping to create drills involving school buses. Training Chief Eric Alvarez is also stated he is working on Fire Marshal and prevention as much as time is allowing. There are a few 2 series classes coming up in 2022 that he is hoping to attend. Tony Madrigal stated he is hoping to get some assistance for Eric to assist with the trainings. Training Chief Alvarez stated he will develop a spreadsheet of classes in hopes of signups for help.

FIREFIGHTERS' ASSOC. REPORT: Association President Aaron Branscomb reported Station 54 Grand Opening was a big hit and thanked board and staff. At the next association meeting, Aaron stated he will ask the association if he wants to do the Halloween drive through again.

CHIEF'S REPORT: Deputy Chief John Thomen reported there was a lot of work put into the open house and it was well attended. There were 56 calls in the month of August. The call volume year to date is 524. Deputy Chief Thomen reported the response has been great and appreciates the assistance from Ridgewood Ranch Fire and Brooktrails Fire Department.
